We have 60 people signed up already. We can't exceed 50 people. We need things like food, pasta, hot dogs, burgers. We need water, lights, grill. Our big expense is tents. People signed up do not have tents. We have two girl tents, two boy tents. We also need to pay for safety equipment. We also have other random expenses. But we look around \$2500 in total. We need money for the boat charter too. The extra 500 is to pay for the future camping trips.

Jorge- Are these permits reusable?

Matteo- no, it's for a single day.

Ryan- The tents will be property of College of Marin?

Matteo- correct. We are hoping to find a spot to store them. But I hope we can find a room

Sadika- I am concerned about the boat thing. I am going to strongly encourage against that. It is not a car.

Ryan- regardless, the money will stay in their account.
