a. Discussion/action COMmon Read book purchase NTE \$2,500 from acct.\#7300.11 (Intrfund MCCD). Presentation by Librarian Dave Patterson.

Fernanda, Emma M.
Dave: I'm a big fan of ASCOM, of course that sounds a little self-serving since I am asking for money, but it is true. I am going to share my screen. I am asking for $\$ 2,500$ and I'd like to use that money to buy more books. Last year ASCOM gave us $\$ 5,000$ dollars to buy COMmon Read books by Isabelle Allende. We bought a Long Petal of the Sea which was written in Spanish. Isabelle Allende is the most popular Latinx writer, and she lives in Marin. She writes in Spanish and her books are translated to English. Thanks to you we were able to buy books, but we realized we are running out. We want to buy her book, Eva Luna, that has 23 short stories. It's about 200 pages long, and each story is about 10 pages. Blaize Woodlief, an English professor, said she's excited to invite Isabella Allende to come to COM. She's coming on Thursday, May 12 at $6: 30$. We need short stories since not everyone wants to read a 300 page novel. We are asking to buy 170 copies of the short stories. We have already used some of the library's money to buy some. This book is not just for Latinx students, but everyone can be proud to live in Marin with Isabella Allende; she's a feminist, she writes about topics important to COM students like immigration, democracy, race, gender. She writes in a captivating way so that students are excited, and they want to be part of a bigger story. So, I'm asking for $\$ 2,500$. It won't break our bank if you say no, but if you say yes, we'll be very grateful. I'd love to take questions if there are any.

## Faiz, Fernanda

We need to make sure that everyone that signed up was able to help and send out the signup sheet earlier. If you're ordering food, make sure to order well in advance because it can take a while to get here.
