Saidy- Hi everyone, I made a little PowerPoint. I attended the student workshop before the ascom retreat. Here are some of the pictures of the hotel. Thank you. Some of the takeaways that I had from the workshop, were that there's different college systems and different resources, I know, like some colleges were saying that they didn't have like food banks, as like we do or like. They didn't have this or that. which was really in interesting to learn. What kind of resources that they had, that we didn't have. Such as having AAPI community. And I also learned what it means in what it takes to be a student trustee. The difference between a student trustee and a regular trustee that comes with responsibilities and how they're elected. We also talked about enrollment, more so of like not, only focusing on high school students, because apparently graduation rates for high school students are dropping. But we should focus on more on like community members that want to continue with college. We also went to legislation rules and how to be more engaged with the SSCCC, and how to be more involved with just overall going to the capital and like advocating for community colleges, since we're one of the lowest funded systems. What's next. I think, for all the presentations and all the resources that they gave me for the press for the during workshop. I'm just gonna put it in the Google drive. So, anyone can access it, and especially future student trustees since some of them might not be able to attend. Though I highly recommend it, because you're able to get a lot of networks and meet on other student trustees. Ryan- Is there like a word requirement for that?

Gavi- About 50 words. Probably a little longer. It has a section on weekly board meetings. with links to agendas and minutes, and I created this little thing prior meeting recaps which I thought we could start doing. Sarah we can talk about it later.

Sarah- Yeah, I can do that, but I also need access to the google drive.

Gavi- Yes, and I will give everyone access to the website, especially Aliyah, because I might kind of need you. I also have been working on the events calendar which is for you Tino and Tshiamo. This will list all the events. I want to talk to you later about maybe writing these things for events. But that's another issue. We have lots of resources for starting a club, all the forms, a list of all the clubs. And if we get to the bottom, you can see. Here's a bit of an example of what the clubs can do with their page.

Sarah- They've already accessed? Or is this from last semester?

Gavi- They sent this stuff last semester. It's in now.

Ryan- And for the forms that are on the website, are they linked?

Gavi- Yeah, they go. If you click on them, they go through. Anyways, short ICC page. I'm going to keep on working on this and a little contact page also goes through the Instagram that's about it.

Tino- So when students want to access this, how are we going to go about this?

Gavi- They will just email me when they want to put stuff in.
Tshiamo- Good job Gavi. We can discuss this later today, but other than that good job!

Gavi- Wait, hold on a few like weekly developments on the other website we might consider adding a student submissions page which was originally intended. But that's kind of complicated and just more resources for students.
k. Discussion/action on ASCOM and Student Activities \& Advocacy marketing support. Presentation by Tea Perales, Equity and Activities Coordinator.

Jessica, Jorge

Tea- In the past few years, ascom has generously provided support around this. So really, it's just asking for funding to print posters that the student activities in office puts on. There are different programs that are really in alignment with Ascom, around student engagement and equity. I'm requesting, if y'all are down to collaborate by simply funding the posters. So, I will be creating all the posters. it's just we'll put ask logo on the poster that hopefully also increase engagements. I know you all are really in touch with students and students are going to really start to know who you all are. It also was promoting the programs on past com social media and just helping promote events. And we're getting more reach to students. It's anywhere from like around 20 to 25 of each order, and it usually only 2 to 3 programs per month, so it could be anywhere from like 50 to 75 per month. So, it ends up being around 250 for the whole semester.

Sarah- Why didn't we do this last semester?

Tea- It was. It's happened for the past few years. It's been successful in the past.

Ryan- So every time you need a printing order, would you put in an agenda item?

Tea- Yeah. Because each order it's usually for 2 to 3 programs. I just provided what the estimate is usually about, so 25 per order. And there's only 2 to 3 programs per month. So, like 75 .

And we're gonna have candy on top of that. And for decorations we're planning to get balloons. So, we're just gonna plant them ourselves. And, tablecloth, we're gonna get them on Amazon.

Sarah- There is also a lot of tablecloths in the shed. They were all green too if that matters.

Ryan- Check the shed before you get certain things.

Gavi- I've been working on wrangling clubs. We have now a list of 5 clubs who would like a table. We have ESCOM, the American Association of University Women, Students for Social Justice, the Architecture Club, and the philosophy club, and I have a few other clubs
which I'm gonna reach out to specifically. So, we've got a pretty good list going. And we're gonna get more. We are already anticipating at least maybe 20 plus clubs.

Jorge- Well, we haven't met yet to start the planning, but we plan to start making the layout. I've experienced doing that, so it shouldn't be much trouble. As the day approaches, we'll also make sure to reach out to the Decoration group.

Sarah- And the student activities form is finally submitted.

Fatimah- Jessica is working on the poster for us, and so she should almost be done. I've been telling people word of mouth to come.

Gavi- The only thing I want us to focus on is to get anything online ordered by next Monday so we can get back on track.
m . Discussion on upcoming programs. Presentation by ASCOM members.
Jessica, Jorge
Ryan- Given that what Gavi just said, we're pretty on track. The bulk of the club fest is getting responses from the clubs that have existed or that are interested in being created. And as Tea and I were talking before the meeting, it's typical for clubs during the fall should be a little bit a little bit slower than it is during the spring, just because people are getting settled in. Sometimes they don't have the chance to, you know, enroll. I mean the semester just getting started. So as long as we stay on top with every single other thing that we have to do in terms of logistics, and making sure that we have all the supplies and all of the food and stuff like that, Clubs will come naturally, and also during Club Fest, it will be an opportunity for clubs to get information from us, and even if they did not get a chance to be at club fest, they can get information on how to start a club at Club fest. So, I think that we are in a pretty good track, and you know, if we take care of the logistics and stuff that we will be providing as ask, call, everything else will come along.

Gavi- I think during the first few days, clubs were pretty slow to get back. But I've been getting emails from maybe 2 or 3 clubs every day saying, "I'm here," and I'm offering all of them tables.

Jorge- Alumni panel group, we haven't started planning yet. That's something we should get on top of. I apologize for that; I should've reached out beforehand. I know Gavi's been busy for the website and with club fest. I'll send a text if you guys could give me availability.

Jessica- That's the one when people who have graduated from COM come right? What day is that?

Ryan- September 20th. Also, just one thing, we changed the way that we do events, this semester. And I think this is something that we are all trying. And you know, like we might have a few hiccups along the way, because it is a bit harder to meet with people when you're meeting with the larger group of people rather than just 3 co-leads, which was the way that we used to do it last semester. So, I really ask, you guys take the lead, and be the first person to reach out of your group and be like, "Hey, can we meet?" Talk about this like, please take the lead. I want everybody to be present and be leaders, you know, like, we are all doing this together. I understand that we have different responsibilities and different duties, but in the end of the day. We are all ASCOM board members, and we all need to take our leads, and we all need to be the first ones to do things. So please do not hesitate to reach out your group. Please do not hesitate to create a group chat. Do not hesitate to emails. Let's keep doing what we're doing. We're doing a great job so far, we're all getting settled in.
