Well, of course I'm in denial. Those numbers are a little bit staggering. So I said, You get the wrong, Kevin. But of course it's true. So, why don't you guys know that and enjoy it? Because I am telling ya, the time flies, and you're in the middle of some great learning periods and your transformations

and you will not believe what you will achieve in the next 10 years. So, thanks.

- c. Discussion on collaborating for Sexual Assault Awareness Month (SAAM). Presentation by Christina Vasquez, Crisis Intervention Program Manager.

Gavi, Tino

Christina- We are your local rape crisis center in Marin County, and so April is sexual assault awareness month. And so what we're hoping to do is to collaborate with the College of Marin and hopefully on both campuses to do an event. And our event we're looking at doing is what we call the close line project. I'm not sure if any of you have heard of the close line project but what it is providing is having a space at the college. People would come in; faculty or students would come in and they would decorate a T-shirt. We would bring all the materials. They can decorate it. They can paint it, draw on it write on it. And because it's sexual assault awareness month. We're hoping they could come in and decorate it on how they feel about it. If they were affected directly or indirectly, or just be in support of the cause. So they can decorate however they want. However, they feel what they want to say. They want to be encouraging. So it's totally up to them. But we would bring all the material and we would also provide counselors on hand as well. So if anybody is triggering, or if it brings up memories, or if they need someone to talk to, we can also have our staff on site. We do have therapists; we have crisis counselors available. We want to do this at both campuses. So what happens after the T-shirts are done; we will display them in the community. So law enforcement has agreed to have them in their lobbies. But we also would want to do, of course, put some out on each campus just for the month of April. And so what we're asking from the school, from the club is to provide a space for us to hold the event. We do have a flier and hopefully you can help with engagement. And then yeah, and also a place to display after the event for the rest of the month. So I'm hoping if maybe, if we can do, maybe the last week of March or the first 2 weeks in April, sometime during those 3 weeks. That would be ideal so it'll give us time to have the displayed in the community. We would bring all the materials we would bring the crisis counselors, we will provide the flyers. We will bring refreshments. So all we're asking is if your help in getting participation and a space to hold the event on each campus and the day it would work for you all.

Ryan- We do have an event coming up on may 6th that can be a very good opportunity to raise awareness. Does it have to be the last week of march or beginning of April.

Christina- the point is to do it for April, but we are available in may.

Tshiamo- end of march is the club fundraiser and we also have AAPI in April. Color run too. It would just be a matter of the co-leads and how you want to host that in April.

Ryan- do you have Sadika's email? Do you have Sarah's email? We would love to partner up with you guys during AAPI and food fest event. But if possible, can we schedule a separate meeting to discuss the logistics and other details? We are willing to collaborate and we believe this is an important cause.

Gavi, Sabrina

Nicole- Hi, everyone. My name is Nicole McIntyre. I'm the director of Mesa here at college of Marin. If you don't know, we're a learning community for students in stem. Specifically, first generation college students. So we're taking a group of students to the women in engineering conference at San Jose State on Saturday, March 16th, and the event has a ticket cost. It's between \$30 and \$40, I think. And we had 2 students who are not a part of the mesa program apply to come, and we would really like to support them in that. Unfortunately, the mesa grant is restricted that we can only spend mesa money on trips for mesa students. So we are requesting \$107 to pay for the tickets for those 2 college of Marin students who are not a part of mesa, and also to pay for them to have a lunch as a community building activity for our women in engineering and preparation of that conference so that they can all get to know each other. Build community as a very small population here on campus, and then we can prepare them for how to go to a 12 hour long

professional conference. So yeah, we are requesting \$107 for lunch and ticket. Transportation will be provided by mesa in a college of Marin van.

Ryan- Thanks, Nicole. How's the 7300 account looking?

Jorge- We have \$4,000.

Gavi, Tino

Jonathan- Thank you for your consideration. We sent the spreadsheet of the breakdown of the campus tours. We put 18 students and found out that we can actually pick 19 students. We received overwhelming amount of interest, like 64 applications. I was a tough decision. This is an important decision and on applications, some say this is their only opportunity. We have the breakdown of the budget. We were planning on flying the students, their rooming, some food. We included the 2 vans for 11 people. We also included an emergency fund in case we are above our budgeting. We also have Yanira, one of our mentors from the MAPS program and she is going to be joining us on this tour.

Yanira- it is really important to have students to see the campus. I feel like it's really important for us students to see like the campus get to know more about it since as first generations, like none of our parents, have no idea how the system works, and like they don't know anything about colleges. So like, I really want to know, like the campus personally. So if I signed up to campus and be like, oh, I'm going here. But what if it's not like what I wanted to like? I don't know a lot of people that been there like I don't know a lot of connections that been to those colleges so like it would be great for me to see the campuses and feel comfortable. I have been to a private college for me, but it wasn't for me. It is good for students to know the campus personally.

Ryan- I resonate with that a lot. You guys are requesting for some funds, and it's free for the students.

Jonathan- yes, if they plan on not buying anything.

Ryan- so it is \$732 per student and \$1096 per counselor. And then \$17,164 for the whole trip? And you're requesting 10,000 dollars. The only thing here is that the account that we have allocated for this is running very low. We would like to support this field trip because this is beneficial. Are you talking to other departments?

Jonathan- We are collaborating with transfer club, with mesa, and so we are all looking for funds. We found southwest credit from the counseling department. The transfer club was able to provide 7,000 dollars. Our student mentors also had a bake sale where they raised 400 dollars.

Tshiamo- I am looking at the breakdown. It says that ascom requesting is 6,200. Where is the 3,800 going towards?

Jonathan- We were going to put 6,200 and then the emergency fund is 700 dollars. And so we are requesting 7,000. Our original plan was for 4 chaperones and 24 students. We were wondering how many we could bring. When I first submitted it, it was 10,000. But we actually need 7,000. I am more on the other side of it, but MESA is handling the funds.

Jorge- We have 4,000 dollars in that account. Sadika said we can pull from the club accounts which has 13,000, but keep in mind that is for clubs.

Tshiamo- have you spoken to community director in terms of getting funds from other communities? There is one that is dedicated to learning communities.

Jonathan- One of the mesa counselors is in charge of the budgeting. I know she worked with Melanie and Nequeshé.

Ryan- you don't want students to pay?

Jonathan- we do not. As much as we can. We included the food on there as well.

Jorge- I don't know. In both those accounts to start with, we had \$42,000. Now we have \$17,000, and those 2 accounts for the rest of the semester.

Gavi- Yeah, we drained one account, I think a club came in and requested 3 grand

Jorge- Whatever we decide we have to take that into account.

Gavi- More clubs will be coming for money.

Jorge- We couldn't even pull from the events supplies account because we use it.

Tshiamo- I totally understand as someone who in a situation to be able to go see the colleges I want to attend. This is a great initiative, but this might be too many students. So if maybe, like Ryan was, I think Ryan was asking or trying to segway into. We know you don't want to do this pay, but it's going to be hard for us to fully give all that money to all those students. So maybe coming to a compromise of decreasing the number of students or have them pay some sort of fee.

Ryan- We have to look at the budget and I think that as a board we can compromise. This is my third semester and I have never heard of a fieldtrip like this. I think we are only able to provide you guys with 2,000 dollars. If other folks have any other comments on this. I did the math and I know you don't want students to pay for it, but with 2,000, you guys

would still have a cost left for the students to pay which is \$233 dollars. We are willing to reach out to other departments.

Jonathan- also I want to include that when we did the application, we didn't want them to worry about money so they didn't have to worry about food. We haven't sent the list of students to our mentor.

Ryan- How many applied?

Jonathan- 64.

Ryan- So, my suggestion is to narrow down the 18 students. Would you be able to see who is willing to pay for their own food?

Sadika- Do you know how many are considered first generation?

Jonathan- I have that information on the application.

Sadika- Let's connect next week so we can get more concrete numbers because I think I can provide another option.

Tino- Morgan is experienced.

Tshiamo- so is Joshua. He has a lot of experience with marketing and creating posters.

Sabrina- can we have Joshua's application?

Ryan- I can send it in our group chat. He sent it by paper.

Tshiamo- Do we know what Chelsey's major is?

Ryan- I can find that out. Communications. Here's the thing, people can come and say anything and we've seen that in the past too, like, we've had people in certain positions that stated that they had extensive experience in a certain area. And then, when it came down to actually working and being in the group environment, it doesn't mean that they're going to be the best at it.

Jorge- Morgan has showed up at our events.

Gio- Is she an auxiliary?

Tshiamo- No. I think Joshua has showed up at a few of our events.

Jorge- I don't know him.

Gio- He is in a class with me. I recommended it to him but I didn't think he would not show up.

Tshiamo- did he know he was supposed to be here?

Ryan- He printed it out and delivered it here.

Sadika- To clarify, I did not see Joshua's election pack. I think it was on my desk, and so he did not know that he was supposed to come here. It's not in the election packet, so it's not on him. So I want to make sure that you all know that Morgan turned in their application yesterday, which was well past the deadline. But is still very qualified. Chelsey and Joshua turned in their applications on time.

Also club reactivation to be reactivated once a year.

Tshiamo- Why change the amount of students from 6 to 4?

Gavi- it is hard to start clubs. It is the consensus from ICC. We are also adding the requirement to meet with Malaika. For stipends, we're looking for an inflation update. We would increase it by the last inflation CPI number. This means that there is a change in amount.

Tea- When the last board updated the stipends amount, they did extensive research around the workload.

Tshiamo- Gavi has been asking around and has looked at the constitution. Do we have to vote on this today?

Ryan- we can vote on making changes for the stipends. We just need approval to make changes to the constitution. This is also for the future board.

Gavi- It is a universal raise around the board.

Ryan- These are Gavi's changes. My changes are around the general language on the constitution. I want to reclassify the groups within ASCOM. We would have the executive group, job descriptions for the student trustee so the meet with the VP about the ICC meetings or attend the ICC meetings. So, these groups would be the executives, event

coordinators, and public media and outreach. It is just the change of the language and small revisions of job descriptions. We just need approval from you are.

Tshiamo- can you add us to any documents? We are voting on the percentages right?

Gavi- We are voting on changing it.


