We are electing a new VP because Gio is transferring at the end of this semester. We have two candidates, which is Al and Ray, and do you want to go first? Y

Al: Okay, I just, want to start and thank each and every single one of you for your support, collaboration, and effort this semester. You guys truly inspired me to do better, not only as a secretary, but as a person. We all have committed ourselves to the events, and it's been great. So I'm really grateful. The reason I'm here today is I've been inspired by your last VP, Gio, to step up. The reason I say that is during the first event I ever co-leaded, the Club Fest. He really showed me what a leader is. He was well-prepared, he was knowledgeable, and he made such a big event with this many clubs. And the reason I think I can do the job is... comes mainly from my experience as the secretary.

As a secretary, as y'all are very aware. I have to do the agenda and the minutes. But that also comes with some extra tests. Let's say, as an example here with the club, they request money, and I have to guide them where the meeting is, when the meeting time is, and answer any questions through email. And a big part of the VP job is to actually be in contact with the clubs. Say, hey, do you need help with, anything? Lead the ICC meeting, so I've already got some experience doing that.

Additionally, I have to talk with our advisors if there are any things to adjust with the formality of the agenda or the minutes that required prompt communication back and forth to make sure that that was turned in by the right date.

On top of it, since I usually do the minutes during the meetings, I have to pay really close attention to how the meeting runs, even sometimes helping Arthur with the formalities on the meeting. So if Arthur, at any point during next semester, needs me to step in and maybe lead a meeting, I feel like I am well prepared due to the minutes.

And, for next semester, actually, I was discussing with Gio early on about the VP, I've been interested for a while, and we want to create a WhatsApp group, so that the people, the clubs feel more, feel closer to us to ask them. I feel like rather than unplug the email inbox, they can just text me, shoot me a text over a number, respond quickly. Again, that prompt communication between me and the clubs, I feel like that will have a greater turnout of people coming to our SEC meetings.

And, as well as...running the events. I feel like this semester, one thing we could have improved on is making sure that people volunteered early, so that the events are as stress-free as possible.

And, I just want to work with that, with Arthur, leading the board, making sure that people are signing up early, and that the events are as stress-free for everyone.

Going off of that, I've known Arthur for a while. Something that the VP requires is a good relationship with the president to lead the board. I've worked with them in classrooms, projects, and I am more than ready to, when the rubber hits the road again, do the work with them.

And I just want to say, again, thank you, everyone, for their effort. I really feel a strong sense of community in here. We're goofing around and playing games after the meeting, it's awesome. And thank you for considering, and I'll be honored to have your vote.

Arthur: Does anyone have questions for Al? Okay, well, I have a question. So, you know, you've been the secretary for...pretty much this entire semester, what do you think's the most important lesson you learned?

Al: Well, the most important lesson I learned is to be organized. Being the secretary requires a great deal of awareness of your email inbox, of your texts, of everything. It's a... you know, sometimes it can be a lot, and again, like I said, not all of the time I got it perfectly. I've had to talk... Sadika knows, like, we talked back and forth about adjusting the agendas. So that organization, being on top of it, being aware, knowing the due dates, that was a really important lesson. And one more was, actually not specifically to the secretary role, but co-leading the events. Leading the events really made us feel closer to the community. That was...I feel like that was a great opportunity for me. Thank you.

Gio: Yeah, I have one question. What would you say your leadership style is?

Al: My leadership style. Well, sure you guys noticed, I like to listen in a lot. I feel like listening is my biggest skill. I... sometimes I can say a lot, but then I feel like most of the time, I'm a strong listener. My friends around me know I really listen in to their problems, so I really like to be aware of what's going on around me, listening in, and I feel like that's an important skill. Sometimes you know, leaders like to talk too much and impose, I feel like. I'm more into, like, hey, you know, like, more chill, like, hey, what do you need, what does the board need, really, like, what is around me?

Marc: If there's a conflict between ASCOM members, how would you handle it?

Well, if there is a conflict, again, tying back to the listening part. I really like to listen to both sides. I feel like in a conflict, there's always two sides of the coin, right? And, to the best of my ability, I could calm myself... try to calm the situation down, scale it down, and then if it's beyond me, I'm more than glad to use my resources. Arthur, the advisors, I feel like we can turn this around. Conflicts aren't uncommon among the boards. We've had a really chill board. However, if... the time comes where it needs to... some escalation needs to be put down, I'm confident in typing in the works.

Jess: So, as I'm sure you are aware, being the vice president is going to be a longer workload than being the secretary. Sure. Do you think you're ready to handle that when combined with your classes next year?

Al: Yeah, actually, my classes, they're a little bit lighter than those classes. Currently, that I'm taking, I've heard Calculus 3 is easier than 2, per se, and Physics 207C is easier than A. So, I think the class will be a little lighter, and the secretary workload's already actually a little bit demanding on the base so I feel like I don't know, yeah, I'll have to experience for myself, but I'm sure I can make the commitment to the VP and leads, yes.

Arthur: Alright, we'll be moving onto Ray.

Ray: Okay, I'm just gonna talk from here, because I feel like I'm more comfortable, so... This is the first time I'm actually nervous, I'm never nervous to speak in front of you guys. And to an extent, it feels like a sales pitch, but I'm gonna try and not give a sales pitch to everyone. And I do have some notes, because it'll help me a little bit more. So, being a tag team partner with Luca, being Senator of Student Activities, I've learned a lot. I think I've learned the importance of planning, organizing, and communicating with everyone, as well as just encouraging members to be a part of this all together and work as a team. I think that having the experience with Luca has really helped, because it's kind of built me that, like, you can lean on someone, and they can lean on you, which is something I would need with Arthur. That would be very important to have that strong communication the way that Luca and I do. I think I could really well, and, like, work well with you. I... I completely see that

we're not, like, we haven't been friends since really young, which is, like, that's...Brownie points to you, Al, but I think that doesn't matter. I think that I didn't know most of the sport, and we've all become really strong, especially, like, Luke and I, for example, working together. I think that a big thing is also recognizing when something goes wrong, when a concern happens, and implementing it straight away to fix it. So, like, for example, we had the event planning where we had some of the people who didn't set up all the tables in time, for our events, and that was a really big issue, and both of you can now be able to tag team and tackle it straight away, and fix it for the future, which has already been done. I think then in terms of strengths and values, so I think that for me. I'm very organized. I think sometimes you guys can see that I'm very organized. I feel like I am responsible, and I'm reliable as well. I know...when I need to pipe up, and when I need a pipe down. I think that encouraging... I've encouraged people a lot, as well as people... people encourage me, and I think value I take a lot of value in relationship and connections, so that's with you guys. I feel like each and one of you, I can have... I can nail one thing about something I know that's different from everyone else, right? And I feel like similar to the community as well. I know a lot of people, which is great, I'm sure, Al, you know a lot of people too. And I think that no matter... apart from just standards of student activities, I try to always go that extra 100% of just, like, you know, at events, maybe it's not my event, but I'm like, hi guys, how are you? Oh, you said this? You know, like, trying to just, like really just be engaged with the community, and like, as much as, like, the vice president is more on the hierarchy scale, whatever you want to call it, I feel like I'm still the same level as all the other students. I feel like I still make people feel really welcome whenever someone comes to the office. I'm like, hi guys! You know, like. Maybe I am busy doing something, but I always feel the need to acknowledge people and communicate with everyone. And I feel like Arthur and I, back to... Arthur and I working together, I think that there is... similar to Gio and Arthur, you guys are complete opposites, and I think that makes you guys very compatible. And in the same sense, Gio, you're amazing. I'm not gonna start on that, because it will never end, but I feel like I...I'm somewhat very similar to you in mirroring everything that you do, the tasks you do, the effort you put in, the everything that you do, I feel like...I could really look up to and, you know, learn from that, and I feel like I have learned from that. And then the most... I'm going to end off with this, because then I'm just going to talk forever and ever, but I think the most thing is, I have a voice as much as I allow other people to have a voice, so when... sometimes when I feel like someone's not heard, I like to be like, oh, Emily, you wanted to say something? Or, oh, yes, what do you... can I help you with something? Let me show you where this place is, or let me show you where that place is, or I try to just go the extra mile of helping outside of my current responsibilities. So I feel like...I could, you know, continue that, and I feel like being a good face for you guys is really important. I feel that I want ASCOM to be like, oh, that's Ray, she's part of ASCOM. Ray is so good at, like, presenting herself. ASCOM's like that. I want to rely on Ray, which means I can rely on ASCOM. You know, it's that whole, like, front face of communicating and public speaking and, you know, just, again, front face. And I think that I really could help with that and, like. Excel it even more than it already is, despite it being really good currently. Does anyone have any questions?
