Stephania: Our office supplies accounts are the same, I subtracted the wagon we bought 2 weeks ago. Total of \$2811, and event supplies, I subtracted the money from midterm, and we have a total of \$9688. Department account \$12,000. Club account \$28,156. I just wanted to tell you that money for the events is for the whole year we have now is \$9,600. If we divide the \$12,000 money, we have \$6,000 per semester. For this semester we have \$3,688 left for the upcoming events.

Gio: We had a pretty big turnout, over 200 people each day. And we calculated that by how many slices of pizza we gave out, meaning a roughs estimate. We had a lot of people coming to me about the club forms and what to do. Now we've had a lot more people coming in to make their clubs official. We had a lot of organizations that came.

Arthur: We started planning a little late, but we caught up. We had an issue with the vendor that charged us above the expected value. And the soda was delivered late. We didn't have enough of them for events, by the time I got there we ran out of sodas.

Gio: So, we worked with facilities, consistently, because there were a lot of moving parts. We added more tables and places. Shout out to Eloisa for consistent communication.

Arthur: We could've communicated more with the food ordering process. Better advertising, Giovanny made them really late, the advertisement could've gone out earlier. Keep track of time and start on week 5 planning. Coordinate better with PR and Marketing, to understand that posters need to go out sooner. The event was great, but it seemed some of the advertising could have gone out a bit earlier, and then more people would have known. Keep track of time, so start the week by planning. It wasn't a huge deal this time, but it's always great to start early. And then include communication channels and questions. So, this is, I guess, more for Club Fest, because we have so many, like, club organizers going to the event. We have, like, some sort of channel where they can just reach us, and if they have any questions about it, like starting a club, or like, whether or not they need to reserve a table.

Al: I just want to give a big shout out to Gio over this event's planning. This dude started planning over the summer, so he could have almost all of it prepared when the time for the event coming. He really showed me the huge amount of experience he acquired from working with ASCOM these last few years. I saw what leadership looked like then. Thank you Gio.

Eloisa: I just want to add, I think for Mountain Mike's, after Club Fest, we figured out a system with them, so they now know my number, so they know to give us the right discount now, so that hopefully has been

I can book that, and then you guys can just have whatever clubs show up, go there instead of them having to reach out individually, because in that, I go over the whole club process, like renewing, starting clubs, so it might help with viewer emails, too, if they know to go directly.
