

Motion to discuss: Al, Jess

Ryan: I'm Ryan Byrne, I am Associate Dean of Student Services, overseeing the Student Health Center. And I'm here today as part of our centennial... as part of our centennial celebration to talk about, the Ideation Challenge. And so, I'm curious if anyone was in the town hall meeting that, President Eldridge hosted, last week on... I think it was Monday? Was anyone there for that? So, I was able to present during that time for the ideation challenge, so I wasn't sure how much to overlap with that, so I wanted to kind of read the room. before I dive into this. I'm going to talk through the ideation challenge, what it is, why we're doing this, and... but the web page really has some great resources. And ultimately, as I... I'm going to kind of finish up in terms of our marketing plan, we're going to be really... the effort's going to be to drive folks to the webpage. But this is really my first, stop in terms of promoting it, aside from the President's Town Hall, as I wanted to share that with... share this with ASCOM, and ask for your help. And, putting this out to... your peers and see if I can get some advice from you all as to how to best market it. We have a marketing plan in place, but, you know, there's always room for fine-tuning. So... Really, as we celebrate our last hundred years, we also want to look forward to the next 100 years and see how students can shape that with some innovation and imagination, and really incentivizing that with a significant prize, as well as the actual implementation of the idea. in, 2026. What we're looking for is something that is outside the box, like unique, bold ideas, something that's going to have a real impact, that makes a difference, makes College of Marin better for students, faculty, and the wider community, or the wider community, I should say. And realistic and achievable. So, it's a... big ideas are awesome, but this should be doable. It should be something that we can implement. So, I wanted to go over some of the details. On this, ideas really could... the types of ideas that we're looking for, can come from anywhere, so it could be something that enhances student experience, improves campus infrastructure, strengthens community engagement, leverages technology and innovation, promotes sustainability, or something totally outside the box, what we're calling our wildcard category. So, anything that you can imagine, we want to hear it. In terms of the mechanics of how this works. Students will submit a simple proposal describing their idea, and you can see there's a link there for submitting your idea here, and that's, if you're interested in taking a deeper dive into that, you can see exactly what's in the web form. It'll include a short action plan, maybe even a list of visuals or sketches or a short video, depending on what the nature of it is. And then, finalists will be invited to present their ideas to a panel of alumni, employees, and community leaders. So, in terms of timeline, as you can see the key dates there, we are looking for... the deadline is December 19th. So, we wanted to kind of strike the right balance of promoting it now, getting it out there, getting the excitement, not having too much lead time until it's the due date, but not everything needs to be, like, 100% fleshed out, like, it is done, like, you're ready to implement, because... you're going to be still presenting to the panelists in the spring if you are selected as a finalist for this, so... You know, really, the short action plan is important; the overall idea is important. Be ready to be able to present on it, but it doesn't need to be totally done. And then, as maybe the most exciting here, we have a significant award, for a grand prize, a \$5,000 award. And what's also coolest is that we are having a commitment to actually implementing the idea. And so, the resources necessary to be able to implement that idea, and featuring it on the website, social media, public recognition at the Centennial Gala, and we also have some runner-up awards of \$2,500 and \$1,000 for second and third place, respectively. So, at this point, I wanted to provide an opportunity to see if I can answer any questions that you may have, and, Any feedback that you may have as we go into next week, we're going to
